

VENDOR/DEALER SPACE AGREEMENT

By signing below or submitting payment, Vendor agrees to all terms herein and at www.cardfestexpo.com.

1. Vendor Package Selection

- ☐ **Standard Floor Table:** One 8ft Table — \$100
- ☐ **Premium Placement:** Two 8ft Tables — \$150
- ☐ **VIP Endcap Suite:** Four 8ft Tables (High Traffic) — \$500
- ☐ **Main Stage Heavyweight Mega-Package:** \$1,500 (Max 2 Available)

2. Space, Load-In & Operations

- **Usage & Subletting:** Displays must stay within assigned footprints and clear of aisles/exits. Subletting, sharing, or transferring space is strictly prohibited without prior written consent.
- **Hours & Load-In:** Setup is strictly 7:00 AM – 8:45 AM on show day. Late arrivals risk space forfeiture without refund. Tables must remain fully staffed during show hours; early teardown is prohibited.

3. Payment, Refunds & Cancellations

- **Non-Refundable:** All payments are 100% final and non-refundable. Assignments are guaranteed only upon cleared payment.
- **Cancellation/Postponement:** If the event is canceled or postponed due to circumstances beyond Organizer's control (acts of God, weather, emergency), fees apply as credit toward a future show. No cash refunds.

4. Security, Property & Loss Waiver

- **100% Vendor Risk:** Vendor retains sole responsibility for all inventory, gear, and cash. Organizer and venue assume **zero liability** for lost, stolen, or damaged items before, during, or after show hours.

5. Insurance & Uninsured Waiver

- **Coverage & COI:** Vendors are strongly encouraged to maintain commercial liability insurance. If insured, submit a COI naming *CardFest Expo LLC (43 Steamwhistle Dr, Ivyland, PA 18974)* as Additional Insured.
- **Uninsured Risk Assumption:** Uninsured Vendors operate at their own sole risk, assume 100% financial liability for injuries, loss, or theft, and waive all rights of recovery or insurance subrogation against Organizer and venue.

6. Merchandise Compliance & Authenticity

- **Zero Counterfeits:** Pirated items, resealed/fake packs, or fake slabs are strictly forbidden. Fraudulent sales result in immediate ejection without refund and referral to law enforcement.
- **Taxes:** Vendor is solely responsible for collecting and remitting all state/local sales taxes.

7. Liability & Indemnification

Vendor agrees to defend, indemnify, and hold harmless CardFest Expo LLC, the venue, and their agents from any claims, losses, thefts, damages, or legal fees arising from Vendor's booth operations, products, or presence.
